Calvary Chapel Christian School FINANCIAL INFORMATION

Calvary Chapel Christian School is a Private School Satellite Program (PSP) serving home schooling families in the Antelope Valley. C.C.C.S. is a member of the CHEA Support Network. We offer two options:

- **OPTION #1** C.C.C.S. for grades K-12.
- Yearly Registration Fee of \$40.00 per family
- Monthly tuition fee of \$18.00 for one student, \$34 for two students, and a \$45.00 cap for three or more students. Tuition is based on a ten-month school year. Tuition payments are typically turned in with your monthly attendance report. **However, all tuition and fees must be paid for each quarter by that quarter's meeting.**
- Enrollment entitles families to receive **all** school services and support group **and** activities.

NOTE: To enroll in this option families must also be current members of Home School Legal Defense Association. www.hslda.org

- o **OPTION #2** Calvary Chapel Christian School Support Group.
- Yearly Registration Fee of \$40.00 per family.
- Enrollment entitles families to be involved with all support group activities: field trips, parties, picture day, monthly newsletter, testing (for a fee), and lending library use.
- **Record keeping, transcripts, diplomas, participation in promotion & graduation ceremony, school IDs, Driver's Education & Driver's Training certificates, work permits and/or affidavit filing **are not** available with this option, only with Option #1.

This is the same support group as in option #1. This option is being made available for families with preschool aged children (5 yrs. and under) that are interested in getting an early start and with socialization with the PSP families enrolled in C.C.C.S., as well as for families that homeschool privately, on their own, and have filed their own affidavit with the state of California. Record keeping and/or affidavit filing are not necessary for families of preschool age children. Enrollment in C.C.C.S. Support Group is determined on an individual basis.

Our purpose is to minister to families that home educate. We seek to do this by being a support and encouragement for families who have made this decision. We desire to be an agent in the strengthening of the abilities the Lord has given you while preserving your independence as parent/teacher.

SCHOOL POLICIES

- 1. Calvary Chapel Christian School is a ministry of Calvary Chapel Antelope Valley. The Christian faith is the foundation of this ministry. All families enrolling in the school shall agree to cooperate with the school's Statement of Faith.
- 2. Both parents shall be in agreement with the decision to home educate your children.
- 3. Parents, understand that CCCS does not offer legal immunity and is only providing school services; therefore, they must agree to maintain membership with Home School Legal Defense as long as they have children enrolled in Calvary Chapel Christian School which is based on Option 1 on page 7 of the Handbook.
- 4. As per Option 2, parents will provide CCCS with a current copy of State of California Private School Affidavit.
- 5. Parents understand that although the school is keeping your children's records, it is in no way responsible for the actual education of your children.
- 6. At least one parent is required to attend each quarterly teacher's meeting. This means that a dad may attend if a mom cannot. Also, children may attend if there is no babysitter. Please keep this in mind!
- 7. Completion, maintenance, and prompt return of required record keeping forms are mandatory. These records ensure that legal requirements are met. Failure to turn in required quarterly paperwork, when due, is grounds for dismissal from CCCS without refund for any fees or tuition paid to-date. Even if you miss the meeting (and incur a "missed meeting fee"), reporting forms have to be received by the principal no later than the first working office day of CCCS principal following that meeting. All quarterly reports will be due within two weeks after the completion of each quarter. Reports received after the Quarterly Meeting will be considered late. A \$20.00 fee will be charged for reports turned in late. If reports (including monthly attendance) are consistently delinquent, termination of enrollment in Calvary Chapel Christian School will be considered and no refunds of tuition and fees paid to-date will be given.
- 8. Monthly attendance reporting is due on the 1st and late after the 5th. A \$10.00 fee will be charged.
- 9. All quarterly tuition and fees incurred on account must be paid for each quarter BY the quarter meetings. This is explained in detail on p. 7 in "Tuition Payments" section.
- 10. CONDUCT-Key words to abide by are <u>courtesy</u> and <u>respect</u>. Children are people too, but no more important than adults and should show respect and be courteous to others and their property. It is the parents' duty to train their children to be responsible persons. Parents should conduct themselves in a Christ-like manner thereby setting a good example for the children to follow.
- 11. Bible is to be taught as an academic subject. Children should also be encouraged to have regular Bible study/ devotions apart from school. CCCS can help you find available options for this if you need help.
- 12. Parents will provide and pay for their own curriculum as needed. Although the lending library is available as well.
- 13. Parents agree to diligently and consistently teach their students a reasonable course of study—<u>parent/teachers</u> agree to teach their student(s) at least three-and-a-half hours per day and provide 180 days of instruction per school <u>year.</u>
- 14. Calvary Chapel Christian School is not liable in any way for injury to parent or child/children on the school premises, or during school activities.
- 15. The services of the school are of mutual consent and either the parent or the school have the right to terminate services at any time by written notification (see p. 12 of Handbook for details regarding withdrawal procedures).

16. Each student may NOT exceed 5 absent days per guarter.

Statement of Faith
