

## Calvary Chapel Christian School

### FINANCIAL INFORMATION

Calvary Chapel Christian School is a Private School Satellite Program (PSP) serving home schooling families in the Antelope Valley. We offer three options:

- **OPTION #1** – C.C.C.S. for grades K-12.

Yearly Registration Fee of \$40.00 per family

Monthly tuition fee of \$30.00 for one student, \$50 for two, and with a \$70.00 cap (for three or more students). Tuition is based on a ten-month school year. **Tuition payments and fees are due with your registration application.** As an option to pay in full, you may choose to pay only the first quarter's tuition fees with your registration application and then continue to pay the rest of the tuition fees at each quarterly meeting. ***(If you choose this option, tuition and fees must be paid by the end of the third quarterly meeting)***

- Enrollment entitles families to receive school services and support group activities **plus a discount for co-op classes.**

**NOTE:** To enroll in this option families must be members of Home School Legal Defense Association. [www.hslda.org](http://www.hslda.org)

**To participate in the Co-op classes the fee is \$150** (\$300 plus \$50 for each additional sibling without discount)

The Co-op will meet once a week every Friday for devotional time, enrichment, traditional course of study, and opportunities for fellowship and socialization field trips, parties, etc. The classes will be led by designated teachers and **parents must be present for children to participate.**

- **OPTION #2** – Calvary Chapel Christian School Support Group.

- Yearly Registration Fee of \$50.00 per family.

- Enrollment entitles families to be involved with most support group activities: field trips, Newsletter, testing (for a fee), and lending library use.

**\*\*Record keeping, transcripts, diplomas, participation in promotion & graduation ceremony, school ID (unless filing individual affidavit with the state), Driver's Education & Driver's Training certificates, work permits and/or affidavit filing, or Co-op classes, parties are not available with this option, only with Option #1.**

This option is being made available for families with preschool-aged children (5 yrs. and under) that are interested in getting an early start and with socialization with the PSP families enrolled in C.C.C.S., as well as for families that homeschool privately, on their own, and have filed their own affidavit with the state of California. Record keeping and/or affidavit filing are not necessary for families of preschool age children. Enrollment in C.C.C.S. Support Group is not for determined on an individual basis.

- **OPTION #3** – Calvary Chapel Christian School Co-Op
- Registration fee \$25 and \$300 yearly fee (\$50 for any additional sibling)

-Enrollment entitles families to the enrichment and course of study classes offered for the school year; plus, involvement with most support group activities.

\*\*Record keeping, transcripts, diplomas, participation in promotion & graduation ceremony, Driver's Education & Driver's Training certificates, School I.D., work permits and/or affidavit filing, and lending library **are not** available with this option, only with Option #1.

The Co-op will meet once a week every Friday for devotional time, enrichment, traditional course of study, and opportunities for fellowship and socialization through field trips, parties, etc. The classes will be led by designated teachers. **Parents must be present for children to participate.**

Our purpose for this program is to minister to our bible believing homeschooling community with academic, and enrichment opportunities outside of the day-to-day school obligations. We want to offer a positive environment for social skill building and fellowship with other believers. Every family must fill a Calvary Chapel Christian School **Co-op** application and sign a statement of faith.

## **Calvary Chapel Christian School Enrollment Information**

We would like to introduce you to Calvary Chapel Christian School, (C.C.C.S.). This packet contains information about enrollment and our school policies. We are a Private School Satellite Program (PSP) and Support Group that has been established as a ministry of Calvary Chapel Antelope Valley. We are a group of families who have come together with the common purpose of educating our children at home and support one another through prayer and fellowship. We desire to provide for our children a Christian education in the home that will prepare and nurture their spiritual growth and to encourage them in their service to Christ.

Our program is not limited to those who attend Calvary Chapel but is open to all families who agree to cooperate with our statement of faith and agree to abide by our guidelines and policies. We require all families to be members of Home School Legal Defense Association (HSLDA). If you are not a member, we will provide an application for HSLDA upon request. Your enrollment is subject to acceptance by HSLDA membership.

### **Steps for Enrollment**

1. Orientation Meeting: This can be done on a one-on-one basis. Only one parent needs to attend.
2. Sign the Statement of Faith agreeing to cooperate.
3. Agree with and sign Calvary Chapel Christian School Policies.
4. HSLDA Membership or renewal (copy of) with membership number and expiration date.
5. Authorization for "Transfer of Records".
6. Complete registration form.
7. Immunization Records (or waiver) and Birth Certificate (we will make a copy).
8. Emergency Health Form.
9. Teacher Qualifications.
10. Registration Fee \$40
11. Photo Release (if participating in Co-op)

# Statement of Faith

## THE SCRIPTURES

We believe that the scriptures of the Old and New Testaments are the Word of God, fully inspired without error and the infallible rule of faith and practice. The Word of God is the foundation upon which the church operates and is the basis by which the church is governed. We believe that the Word of God supersedes any earthly law that is contrary to the Holy Scriptures (Isaiah 28:13; Nehemiah 8:8; John 17:17; II Timothy 3:16-17; Hebrews 4:12; I Peter 1:23-25; II Peter 1:3-4, 21).

## THE TRINITY

We believe that there is one living and true GOD, eternally existing in three persons: The Father, the Son, and the Holy Spirit, equal in power and glory; that this triune God created all, upholds all, and governs all things (Genesis 1:1; Deuteronomy 6:4; Isaiah 44:8, 48:16; Matthew 28:19-20; John 10:30; Hebrews 1:3).

## GOD THE FATHER

We believe in the person of God the Father, an infinite, eternal, personal Spirit, perfect in holiness, wisdom, power and love; that He concerns Himself mercifully in the affairs of men; that He hears and answers prayer; and that He saves from sin and death all those who come to Him through Jesus Christ (Deuteronomy 33:27; Psalm 90:2, 102:27; John 3:16, 4:24; I Timothy 1:17; Titus 1:3).

## GOD THE SON

We believe in the person of Jesus Christ, God's only begotten Son, conceived by the Holy Spirit. We believe in His virgin birth, sinless life, miracles and teachings, his substitutionary atoning death, bodily resurrection, ascension into heaven, perpetual intercession for His people and personal, visible return to earth (Isaiah 7:14; Micah 5:2; Matthew 1:23; Mark 16:19; Luke 1:34-35; John 1:1-2, 8:58, 11:25; I Corinthians 15:3-4; I Timothy 3:16; Hebrews 1:8; I John 1:2; Revelation 1:8).

## GOD THE HOLY SPIRIT

We believe in the person of the Holy Spirit, Who came forth from the Father and Son to convict the world of sin, righteousness, and judgment, and to regenerate, sanctify and empower for ministry all who believe in Christ (John 16:8-11; Acts 1:8; Romans 8:26, 15:13, 16; II Corinthians 3:18; Hebrews 9:14). We believe the Holy Spirit indwells every believer in Jesus Christ and that He is an abiding helper, teacher, and guide (John 16:13, 14:16-17, 16:8-11; Romans 8:26). We believe in the Baptism with the Holy Spirit as a distinct and separate experience to that of regeneration, occurring either subsequent to or simultaneous with salvation, evidenced by a greater dynamic in the Christian's life, enabling that person to be a bold and more effective witness. The supreme evidence of the Spirit-filled life is the fruit of the Spirit, love. We believe in the present day ministry of the Holy Spirit in regard to the exercise of all biblical gifts of the Holy Spirit according to the instructions given to us (I Corinthians 12-14).

## SIN

We believe that all people are sinners by nature and choice, falling short of God's standard and breaking His commandments – and therefore are under God's righteous judgment. Yet, God saves and gives new life to all who come to Him in repentance and faith, trusting in the Person and work of Jesus Christ. At the

cross, Jesus Christ died in our place as our substitute, absorbing God's wrath that should have come upon us. Because Jesus died for the sins of the world the invitation to believe is open to all, and whoever desires may come unto Jesus for new life and the forgiveness of sins (Matthew 11:28; John 3:16; Acts 3:19, 20:21; Romans 3:23; Ephesians 2:1-3, 8-9; I John 2:2; Revelation 22:17).

## MALE LEADERSHIP IN THE CHURCH

We believe in the pattern and principle of male leadership and responsibility in both the home and the church, according to the sacrificial example of Jesus. We believe this limits the roles of pastoral leadership and doctrinal authority to qualified men (I Corinthians 11:1-12; I Timothy 2:1-15). We believe in the universal church, the living spiritual body, of which Christ is the head and all who are born again are a part of the Body of Christ (I Corinthians 12:12-13; Ephesians 4:15-16).

## ORDINANCES

We believe that the Lord, Jesus Christ instituted two ordinances for the church: the full-immersion water baptism of believers and the Lord's Supper (Matthew 28:19; Luke 22:19-20; Acts 2:38; I Corinthians 11:23-26).

## HEAVEN AND HELL

We believe in a literal Heaven and a literal Hell and that all those who place their faith, hope and trust in Jesus Christ will spend eternity in Heaven with the Lord. Those who reject Jesus' free gift of salvation will spend eternity separated from the Lord (Psalm 9:17; Matthew 5:3, 5:22, 18:9, 25:31-34; Mark 9:42-49; Luke 12:5; John 3:18; Hebrews 12:23; I Peter 1:4; Revelation 14:10-11, 20:11-15).

## CHRIST'S SECOND COMING

We believe in the Second Coming of Jesus Christ, which is His personal, visible return to Earth and the establishment of His millennial kingdom, in the resurrection of the body, the final judgment and eternal blessing of the righteous and endless separation of the wicked (Matthew 16:27; Acts 1:11; Revelation 19:11-16, 20:11-15). We believe in the Pre-Tribulation Rapture of the Church where all believers will meet the Lord in the air and be taken out of this world prior to the Tribulation that will come upon the earth (Isaiah 26:20; Matthew 24:29-31; Luke 21:36; Romans 1:18, 5:9; I Thessalonians 1:10, 4:13-16, 5:9; II Peter 2:7-9; Revelation 3:10, 5:7-10, 7:13-14).

## MARRIAGE

We believe that God created man and that He created them male and female. As such, He created them different so as to complement and complete each other. God instituted monogamous marriage between male and female as the foundation of the family and the basic structure of human society. Therefore, we perform marriages in accordance with the Bible consistent with the Old and New Testament (Genesis 2:24; Matthew 19:4-6; John 4:16-18; Romans 1:18-32; I Corinthians 5:11, 6:9-11, 18-20, 7:1-3, 8-9; Galatians 5:19-21; Ephesians 5:3-7; I Timothy 1:9-11).

## **SCHOOL POLICIES**

1. Calvary Chapel Christian School is a ministry of Calvary Chapel Antelope Valley. The Christian faith is the foundation of this ministry. All families enrolling in the school shall agree to cooperate with the school's Statement of Faith.
2. Both parents shall be in agreement with the decision to home educate your children.
3. Parents, understand that CCCS does not offer legal immunity and is only providing school services; therefore, they must agree to maintain membership with Home School Legal Defense as long as they have children enrolled in Calvary Chapel Christian School which is based on Option 1 on page 7 of the Handbook.
4. As per Option 2, parents will provide CCCS with a current copy of the State of California Private School Affidavit.
5. Parents understand that although the school is keeping your children's records, it is in no way responsible for the actual education of your children.
6. At least one parent is required to attend each quarterly teacher's meeting. This means that a dad may attend if a mom cannot. Also, children may attend if there is no babysitter. Please keep this in mind!
7. Completion, maintenance, and prompt return of required record-keeping forms are mandatory. These records ensure that legal requirements are met. Failure to turn in required quarterly paperwork, when due, is grounds for dismissal from CCCS without refund for any fees or tuition paid to-date. Even if you miss the meeting (and incur a "missed meeting fee"), reporting forms have to be received by the principal no later than the first working office day of CCCS principal following that meeting. All quarterly reports will be due within two weeks after the completion of each quarter. Reports received after the Quarterly Meeting will be considered late. A \$20.00 fee will be charged for reports turned in late. If reports (including monthly attendance) are consistently delinquent, termination of enrollment in Calvary Chapel Christian School will be considered and no refunds of tuition and fees paid to-date will be given.
8. Monthly attendance reporting is due on the 1st and considered late after the 5th. A \$10.00 fee will be charged.
9. Full tuition or first quarter's tuition is due at registration. All other quarterly tuition and fees incurred on account must be paid in full BY the third quarter meeting. This is explained in detail on p. 7 of booklet in "Tuition Payments" section.
10. CONDUCT-Key words to abide by are courtesy and respect. Children are people too, but no more important than adults and should show respect and be courteous to others and their property. It is the parents' duty to train their children to be responsible people. Parents should conduct themselves in a Christ-like manner thereby setting a good example for the children to follow. (Co-op students should follow classroom rules including no cell phones during instruction)
11. Bible is to be taught as an academic subject. Children should also be encouraged to have regular Bible study/ devotions apart from school. CCCS can help you find available options for this if you need help.
12. Parents will provide and pay for their own curriculum as needed. Although the lending library is available as well.
13. Parents agree to diligently and consistently teach their students a reasonable course of study—parent/teachers agree to teach their student(s) at least three-and-a-half hours per day and provide 180 days of instruction per school year.
14. Calvary Chapel Christian School is not liable in any way for injury to parent or child/children on the school premises, or during school activities.
15. The services of the school are of mutual consent and either the parent or the school have the right to terminate services at any time by written notification (see p. 13 of Handbook for details regarding withdrawal procedures).
16. Each student may NOT exceed 5 absent days per quarter.
